# **Calls for Community Policing Funding**

You may have seen the launch of <u>EU Horizon funding for community</u> <u>policing</u> which aims to fund one project across 3 EU and Associated Countries (including the UK) up to 4m Euros. We are interested in partnering with police colleagues who may be considering applying apply for this funding which is labelled as <u>HORIZON-CL3-2023-FCT-01-03</u>: <u>New methods and technologies in service of community</u> <u>policing and transferable best practices</u> (pg 21-22).

Topics which we would be looking to cover are:

- Negative factors in local communities are identified early, possible threats are detected, and crime reporting is enhanced;
- Better recognition for community diversity within neighbourhoods, and tailored approaches to milieus including communities traditionally not engaged with statutory authorities resulting in comprehensive community empowerment;
- Identification and EU wide dissemination of validated community policing best practices;
- New methodologies, tools and adoption of technological support are developed;
- Training curricula for Police Authorities are developed on community policing in non-homogenous local milieus with social complexities, including balancing of majority needs while recognising expectations of minority needs while recognising expectations of minorities and/or sub-groups.

There is another funding stream regarding 'Enhancing tools and capabilities to fight advanced forms of cyber threats and cyberdependent crimes'. This may be more relevant for Action Fraud, but some of you may be looking into it too. We do have capacities to identify different segments of communities, and to send targeted messages to actively prevent people falling victim to cyber-crime.

If your police force is looking into creating a consortium for this funding, please contact Kate, who would be happy to discuss how you could utilise Neighbourhood Alert within your bid. Kate has previously been part of a consortium with Citizens Advice and other EU partners who was successful in securing the funding, and as such understands some of the complexities linked to the application and delivery process.

# 2023 Alert National Survey
