# **Website Service Interruption**

Between the maintenance hours of 01:00 and 07:00 Saturday 13<sup>th</sup> August we had a scheduled system upgrade which we anticipated would actually be completed within around 2 hours.

### What we are doing?

We have been upgrading the server/cabinet space available to us to a much larger suite, (still within our Manchester data centre), in order to house new servers and infrastructure. The impact will be to increase the data we store and the response speed of your Alert website.

### What went wrong?

Unfortunately during the physical server move to the new location our Server Manager has experienced technical issues relating to routing the IP addresses to the new location. Rather than the planned single process to swap all the routing, we have had to update each of the sites IP addresses manually, one at a time.

### What's the impact?

It impact of this is that your Alert site has been offline longer than anticipated between the hours of 08:00 and 12:00 midday today.

Message sending was not affected during this incident.

I am very sorry about the interruption to the service our technical team have been doing everything possible to rectify the situation as quickly as possible. If you notice any error pages or inactive services after noon today, please do not hesitate to call our emergency
