



# NEIGHBOURHOOD ALERT DEV BOARD UPDATE: 37: MESSAGE SHARING DEFAULT

Date: 30<sup>TH</sup> October 2018

Happy Halloween to all of you, I hope you had an event-free peaceful week without too many headaches (of any kind). I have crammed three main points into this update for you.

- 1) Change to the Sharing Process
- 2) Incommunicados Purge
- 3) Conference feedback & Save the date

## It's good to share!



At the October Development Board we raised a proposal that the default position of the "Share" button" on the RAPPORT admin be changed to "Share". It is currently set to "Don't share" when you first arrive on this screen. This means that if officers using Rapport do not have the confidence or understanding to change this simple setting, messages are not enabled to be forwarded by recipients onto their own social media accounts.



When message recipients receive your Alerts, the Share button enables them to forward and post your Alerts directly into relevant Facebook Groups, Timelines, Pages, Twitter, Whatsapp and more. If those Alerts are not marked as suitable to "Share" then all of the above social media buttons are disabled.

We know from lots of feedback to our support desk that not marking messages as suitable for sharing (when they clearly are) is extremely frustrating for users who want to help by getting the word spread. We also know that those partners that do send "shared" messages are doing a fantastic job of reaching the wider, social media audience as these two stats testify:



The Development Board unanimously agreed that we could make this change and have the Share option the default position (rather than "Don't share"). Please take note that this will **take effect from Monday 12**<sup>th</sup> **November**. You may wish to advise your administrators regarding this small change in process.



### Note for the near future (and the app)

We are running trials of a much simpler way to generate a tweet and Facebook post to authorised accounts during the standard message sending process. This will give you the ability to control which accounts your administrators post to (if any) and enable a lot of confusion and duplicated process to be removed.

It's a free, new facility built into Rapport that is one of a few measures we have to encourage the use of social media by your front line officers but within a framework that you control. The tweets and Facebook posts are created in the same massaging process but will have their own content, the benefit is that they will link to your Alert post and (where applicable) your force site. You can also create a tweet or Facebook post without creating an "Alert" where necessary.

The new process will enable messages to be posted to selected Twitter and Facebook accounts rather than simply to @alertmessages or other

standard accounts. This will not interfere with your Social Media monitoring facility (whichever one you use) but it will give you much more flexible control over who can tweet and share and to what accounts.

All you will need to do is use a simple Alert admin to authorise your accounts and decide which admins have access to each. Please contact me to discuss how you would like your system for Social Media broadcast setting up.

## Incommunicados Purge



Further to our notification six months ago, we are about to remove the following data from the national database:

Any user that has been incommunicado for over three months and who are not Neighbourhood Watch Coordinators or Deputies

This equates to just over six thousand people **nationally** so will remove some dead data from everyone's datasets. Neighbourhood Watch asked us to hold off from doing this earlier this year as we intended to purge them in May in line with our GDPR processes. MSAs have been working hard to update the incommunicados and the data loss is greatly reduced thanks to their work. This purge will take place next week on: **Friday 9**<sup>th</sup> **November 2018** 

## Thank you for your Conference feedback.
