This is a quick note to provide details regarding yesterdays V4 Pilot Review virtual meeting.

61 people managed to attend, representing 21 police force areas and various other organisations. The 2.5 hour meeting included some superb first hand reviews from North Wales, West Mercia and Northamptonshire forces.

We explained the new elements provided within the V4 system and described the migration process. We had a guest presentation from Rhiannon from CACI who explained the Acorn geo-demographic and wellbeing data sets and I gave a quick demonstration regarding how Acorn and origins data can be applied to engagement strategy on the system.

We answered a few very useful questions from several forces regarding the transition and I am assured the meeting was really positive and left people excited about the migration.
