Version 4 (V4) Progress Update



Our new project delivery team have compiled a detailed working document covering every aspect of V4 development, broken down by core development area for each of the version 4.0, 4.1 & 4.2 releases. This will be continually updated by the project team here at VISAV to ensure every element of V4 is in a timely manner having undergone as much user testing as possible.

Version 4.0 Project Plan:

Last week I shared with you our V4 development timeline (copy below for your information). The project team have taken a long hard look at the numerous elements that make up the Alert system, this is an extremely long list of bespoke elements developed over a decade of providing the system. As each week passes, the size of the job becomes clearer and the time estimates more accurate. The current workstream updates project that we are now 40% through the build of Version 4.0 with an estimated release time of **very early April**. We will have a more precise release date for Version 4.0 next week considering the fluidity of the overall project and that the initial V4.0 includes all the core systems.



V4 Practitioner Group Nominations Update



Thank you to those of you who have already submitted your nominations for the tester practitioner group. We have had a positive influx of nominations since last week's update and look forward to receiving more over the coming days. February National Survey



We are currently working on the National Survey which will be sent out in February. As well as providing valuable data and insight into users perception of Neighbourhood Alert and the communications they receive, we will also be using the survey as a platform to recruit an opted-in group of end-user testers to scrutinise and feedback on all aspects of V4 development prior to Version 4.0 being released. With a target of 100,000 testers this will

enable us to be 100% confident on the robustness of V4 prior to its official live launch.
