Hello from all at VISAV.

Tis the week before Christmas, so this is a quick update to thank you for your ongoing and valuable custom and for all that you do to keep people safe (it's not always appreciated) and to wish you a fabulous 2022.

2021 at VISAV

It has been a challenging year for us at VISAV, COVID has caused its fair share of obstacles as the whole development team now work from home but, I must say they have taken this on admirably.

Losing Andrew came as a huge shock to us all as he was such a life force. Thank you to everyone that responded to my last message with condolences, I duly passed those on to Andrew's widow, daughters and extended family during the epilogue I was honoured to present at his celebration of life service. We are adjusting to working life without Andrew's driving force, but Sue Sambells is doing a great job picking up with the renewals' role.

We have delivered just over **100 million emails** on behalf of our (now) 30 forces during 2021, another new record. We have also broken the **1 million registered members** target which is amazing. Our small team have received and dealt with 25,712 support tickets and % have been marked as excellent". Jon and the dev team have also spent a bit of time on something called V4, which I suppose deserves a mention 😊.

Finally, those amazing MSAs at Neighbourhood Watch have spent an estimated 50,000 hours on the database keeping it accurate and useful for you, this equates to a volunteer contribution of £445K nationally! I will pass on your thanks to them.

Privacy Policy Update National Message
