## Police Assured Secure Facility (PASF) Accreditation:



We are very pleased to advise you that we have recently renewed our PASF accreditation at both our data centre and VISAV office in Nottingham. A big thank you to Layla Hughes, Vetting & Security Manager at Lincolnshire Police who visited both locations to carry out the assessment. ## Local Priority Targeting:



Over the past few weeks we have been working with Humberside Police to develop a new local priority targeting method. Aimed primarily at Inspector level this will enable more relevant local targeting based on team membership, with the criteria base including any answer from any of your surveys (for those of you who use Community View) i.e. low confidence, fear of crime etc. This can also include Origins ethnicity types to allow penetration into hard to reach communities, and Acorn data for socio-geodemographic targeting.

We will demo this in full at the next meeting to give you an insight into the full capabilities.

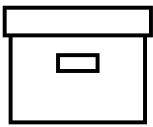
